- **Park Committee Change in Pavilion Rental Fee:** Diana Blume, Chairman of the Park Committee advised the Board that the Park Committee is making a change in the Pavilion rental fee from \$50.00 per rental to \$75.00 per rental to cover the cost of disposing of trash and payment for the cleaning of the bathrooms by the Township Maintenance Department.

## REPORTS TO THE BOARD

- Sewage/Zoning – 6 Sewage Permits and 1 Sewage permit was issued in March 2019.
- Building Permits – 0 Residential issued in February 2019.
- Road Department – Waco is starting to change culvert pipes to prepare for the major paving project. Dirt & Gravel project may be starting before the end of April. The delay is starting the project was an illegal driveway placed in the right away without a permit. It will take some time to clear up that problem. Currently we are working with only one truck which is the Ford. The Dodge is in the shop for brakes, break lines and rotors. The check engine light has been on all winter. The Freightliner was a problem with the dump body since it is rusted to the point where the tailgate will not stay shut. Road Master has requested that the Board send Ordinance #38 to the Planning Committee to be revised to flow with other ordinances such as the SALDO. **Motion** to direct Ordinance #38 to the Planning Committee to review and revise the ordinance specifically for driveway encroachment requirements, made **by Vice-Chairman Fluhr, second by Supervisor Hoeper, motion carried.**

- **John Hahn:** Asked if the Special Meeting was advertised and open to the public. He further asked if the materials sold from the Police Department were put out to bid.
