- **Bruce Baker:** He asked the Board for recommendations for locations of summer programs that feeds kids during the summer. They are looking for lunch programs for roughly 1500 children in the Delaware Valley School system.

- **Chairman Raser** advised the public that Governor Wolfe wants to tax residents for State Police services, so contact your local legislators to advise them that this is a bad idea.
