Details on how this ambulance would work was provided by Fire Chief Jeff DeGroat and details of the staffing of said ambulance was provided by Kyle Mihalik, the owner of CMG Enterprises. A detail on how this ambulance and staffing will be paid for was presented by Township Treasurer, Diana Blume. A number of questions on the details of the new ambulance service was asked by the public. Chairman Fluhr as well as Supervisor Raser thanked all the employees and CMG Enterprises for their efforts in bringing EMS services back to Shohola. No formal action taken.
